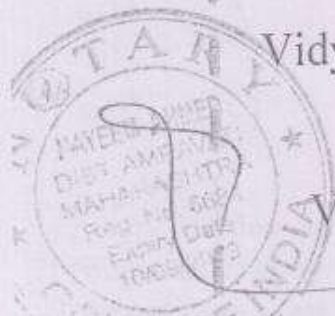

## ARTICLE-I

### OBJECTIVE

The parties, subject to the terms of this Memorandum of Understanding and the laws, rules, regulation and national policies from time to time in force, agree to strengthen, promote and develop co-operations in the field of Ayurved system of medicine between the two Institutions.

## ARTICLE-II

### AREAS OF COOPERATION

Each party will, subject to the laws , rules , regulation and endeavor to take necessary steps to encourage and promote co-operation in the following areas and /or forms:

- (a) In conducting research studies in Ayurved with respect to the priority research areas of Vidyabharati College of Pharmacy, Amravati will be decided after consensus of both the parties,
- (b) This collaborative research studies in central animal house of Vidyabharati College of Pharmacy, Amravati
- (c) Student exchange to perform animal studies at central animal house of Vidyabharati College of Pharmacy, Amravati
- (d) To utilize the central animal research facility of Vidyabharati College of Pharmacy, Amravati for mutual research
- (e) Faculty and student exchange in various areas of mutual interest and benefit
- (f) Any other areas and /or forms of co-operations mutually agreed upon by the parties for promotion of Ayurved.

## ARTICLE-III

### FINANCIAL ARRANGEMENTS

The financial arrangements to cover expenses for the identified research activities undertaken within the framework of this Memorandum of Understanding shall be mutually agreed upon by both the parties on a case -by-case basis subject to availability of funds

## ARTICLE-IV

### PROTECTION OF INTELLECTUAL PROPERTY RIGHTS

- (a) The protection of intellectual property rights shall be enforced in conformity with the national laws , rules and regulations.
- (b) Not with standing anything in paragraph (a) above the intellectual property right in respect of any technological development and any product and services development , carried out



- (i) Jointly by the parties or research result obtained through the joint activity effort by the parties, shall be jointly owned by the parties in accordance with the terms to be mutually agreed upon and
- (ii) Solely and separately by the party or the research results obtained through the sole and separate effort of the party, shall be solely owned by the party concerned.
- (iii) The terms and condition in the execution of the research projects shall be decided on case to case basis

## ARTICLE-V

### CONFIDENTIALITY

Each party undertake to observed the confidentiality and secrecy of documents information and other data received from or supplied to the other party during the period of the implementation of this Memorandum of Understanding or any other agreements made pursuant to this Memorandum of Understanding.

- b) Both parties agree that the provisions of this Article shall continue to be binding between the parties notwithstanding the termination of this Memorandum of Understanding

## ARTICLE-VI

### REVISION, MODIFICATION AND AMENDMENT

- a) Either party may request in writing a revision , modification or amendment or all or any part of this Memorandum of Understanding
- b) Any revision , modification or amendment agreed to by the parties shall be reduced into writing and shall form part of this Memorandum of Understanding
- c) Such revision , modification or amendment shall come into force on such date as may be determined by the parties and
- d) Any revision , modification or amendment shall not prejudice the rights and obligations arising from or based on this Memorandum of Understanding prior or up to the date of such revision , modification or amendment

## ARTICLE-VII

### SETTLEMENT OF DISPUTES

Any difference or disputes between the parties concerning the interpretation and /or implementation and /or application of any of the provision of this Memorandum of Understanding shall be settled amicably through mutual consultation and/or negotiation between both the parties.

## ARTICLE-VIII

### ENTRY INTO FORCE, DURATION AND TERMINATION

- (a) This Memorandum of Understanding shall come into force on the date of signing and shall remain in force for a period of Ten (10) years. Willingness to extend the MoU for a specified period may be initiated six months in advance and further agreed by both the parties
- (b) Notwithstanding anything in this Article, either party may terminate this Memorandum of Understanding by notifying the other party of its intention to terminate this Memorandum of Understanding by a notice in writing at least three (3) months prior to its intention to do so and
- (c) The termination of this Memorandum of Understanding shall not affect the implementation of on-going activities and /or programmes which have been agreed upon before the date of the termination of this Memorandum of Understanding.


